18 The Maricopa County's Office (MCAO) respectfully requests that this court  
19 reconsider a portion of its Order Granting Continuance filed this date. MCAO is  
20 not requesting that the court reconsider its decision to continue the trial  
21 previously scheduled for February 25, 2013.

22 It is requesting that the court reconsider its decision to reset the hearing to  
April 15, 2013.

1 During the course of today's hearing Deputy County Attorney, Colleen  
2 Connor, informed the court that MCAO had a conflict during the period from April  
3 17-30, 2013. In fact, undersigned counsel will be outside of Arizona during a  
4 portion of this period. The court and counsel then discussed the possibility of  
5 resetting the trial to a date in early May. The court and counsel seemed to agree  
6 that if the motion was granted (over MCAO's objection) then the case would be  
7 continued to May 7, 2013. Therefore, it is respectfully requested that this court  
8 partially reconsider today's Order Granting Continuance, and continue this  
9 hearing to May 7, 2013.

10 MCAO further requests that the Court issue an Order indicating that  
11 subpoenas previously issued and served by any party shall remain in effect  
12 through the new trial date.
