14 hereby respectfully notify this Court pursuant to A.R.S. § 41-1092.06(A) that is seeks to set an
15 informal settlement conference in this matter. This request is filed within twenty (20) days prior
16 to the administrative hearing as required under the rule.

17 A.R.S. § 41-1092.06(A) requires that a request for an informal settlement conference be
18 filed with the agency no later than twenty days before the scheduled hearing. “If an informal
19 settlement conference is requested, the agency shall notify the office of the request and the
20 outcome of the conference.” A.R.S. § 41-1092.06(A). In this case, it is believed that the
21 “agency” is the Arizona Secretary of State’s Office; however, the case was transferred to the
22 Yavapai County Attorney’s Office. As such, this Notice and Request is being filed in this case
23 and served upon both agencies. According to A.R.S. § 41-1092.06(A), the agency is required to
