18 The Arizona Department of Health Services, Bureau of Emergency Medical Services and  
19 Trauma System ("BEMSTS") by and through undersigned counsel respectfully requests a  
20 prehearing status conference in the above captioned matter.

21 An initial prehearing conference was held on July 26, 2017 to determine pending  
22 motions for intervention and other outstanding administrative issues. While some of these items  
23 were resolved at that prehearing conference, others such as AMR's Motion for Intervening Party  
24 Status remained open. Subsequently, Dignity filed an Application for Preliminary Injunction  
25 with the Maricopa County Superior Court to prevent AMR's intervention in this matter. On  
26 October 13, 2017 counsel for AMR submitted to this tribunal a Notice of Filing Maricopa  
27 County Superior Court Ruling Denying Dignity's Application for Preliminary Injunction, listed

1 as document 40 in the electronic case file. Responses to that filing followed, and are found at  
2 documents 41-44 in the electronic case file. Since that time, the parties have contacted  
3 BEMSTS for information on moving this matter forward.

4 Therefore, BEMSTS requests that a second prehearing conference be scheduled in order  
5 to address any outstanding motions for intervention and other administrative matters that must  
6 be resolved prior to scheduling a hearing.
