2 (ComTrans Ambulance Service, Inc. dba . . .), CON 66 (Southwest Ambulance of
3 Casa Grande, Inc. dba . . .), CON 75 (Emergency Medical Transport, Inc. dba . . .)

11 Nos. 2018A-EMS-0033-DHS and 2018A-EMS-0034-DHS, certain wholly owned
12 affiliates of American Medical Response, Inc., Arizona CON holders who have been
13 allowed to intervene herein, were consolidated, which consolidation included the
14 termination of four CONs: CON 46, 66, 75 and 86, as follows:

5 dba . . .) were consolidated into CON 71 (Professional Medical Transport, Inc.
6 dba...), and then terminated. The full legal name of the holder of CON 71 was
7 contemporaneously amended such that the entity that holds CON 71 is now known
8 as “Professional Medical Transport, Inc. dba PMT Ambulance dba Life Line
9 Ambulance dba ComTrans Ambulance Service, Inc. dba ComTrans Ambulance
10 Service dba Promed Transport dba American ComTrans dba American Medical
11 Response dba AMR.”
