19 Pending before the Office of Administrative Hearings is the Stipulated Motion
20 Requesting Entry of a Case Management Scheduling Order Re: (1) Change in Hearing
21 Dates; (2) Change in Case Deadlines; and (3) Designation of Hearing Location. Good
22 cause appearing,

23 **IT IS ORDERED** vacating the current hearing dates of July 30, 2018, through
24 August 3, 2018; August 20, 2018, through August 24, 2018; and September 10, 2018,
25 through September 14, 2018.

26 The parties' stipulated hearing dates included October 9, 2018, through October
27 12, 2018; however, the assigned Administrative Law Judge is scheduled to attend a
28 conference out of state on those dates. The parties' stipulated dates also included
29 October 26, 2018, but the facility at which the hearing will be held is not available on
30 that date. Aside from normal holidays, the Administrative Law Judge does not
anticipate being out of the office on any other days after the week of October 9, 2018.

1 The hearing facility is not available on the last Friday of the month due to previously
2 scheduled hearings taking place. Accordingly,

3 **IT IS FURTHER ORDERED** setting the hearing to convene at 9:00 a.m. on
4 October 22, 2018, through October 25, 2018; and October 29, 2018. Additional
5 hearing days will be determined upon the agreement of the parties.

6 **IT IS FURTHER ORDERED** the following remaining deadlines are reset:

- 7 1. September 13, 2018, Parties submit final list of witnesses, with a fair
8 summary of each witness's proposed testimony, and final exhibit lists with
9 the exhibits.
- 10 2. September 20, 2018, Parties file any prehearing motions and legal
11 memoranda. Other parties have five business days to respond to any
12 motions received. No replies will be accepted,
- 13 3. October 15, 2018, Parties fill state of the law, rules, or policy relied on in
14 support of its position.

15 **IT IS FURTHER ORDERED** the hearing in this matter will convene at a facility
16 secured by the Arizona Department of Health Services. Office of Administrative
17 Hearings staff will separately inform the parties of contact information for the individual
18 arranging the hearing facility.
