19 Pursuant to Case Management Order No. 5 (“CMO 5”), the ALJ set hearing dates
20 of October 22, 2018 through October 25, 2018 and October 29, 2018 for the first week
21 of hearing. CMO 5 also allowed for additional hearing days to be determined upon
22 agreement of the parties.

23 RBR Management LLC, dba Community Ambulance (“Applicant” or
24 “Community Ambulance”), the Arizona Department of Health Services (“ADHS”),
25 Bureau of Emergency Medical Services and Trauma Systems (the “Bureau”), and
26 Intervenors ABC Ambulance, LLC (“ABC”), the AMR CON Holders (“AMR”), and
27 Maricopa Ambulance, LLC (“Maricopa Ambulance”) (collectively the “parties”) hereby
28 request the setting of five additional hearing dates. The parties have agreed to the
additional hearing dates of November 5, 2018 through November 9, 2018.

Also, there having been no date ordered for responses and objections to
subpoenas, the parties agree that any and all subpoena responses not covered by a

1 receiving party's objections, and any objections/motions to quash shall be filed and
2 served by July 25, 2018.

3 The parties therefore request entry of a case management order setting the
4 deadline for (non-objection) responses and motions to quash/objections to subpoenas for
5 July 25, 2018 and setting five additional hearing dates from November 5, 2018 through
6 November 9, 2018.
