27 conferred and do hereby stipulate and agree to extend the post-hearing briefing

1           **Monday, January 28, 2019** – All parties are to submit their written  
2 closing arguments and proposed findings of fact and conclusions of law by 5:00  
3 p.m. on Monday, January 28, 2019, with the WORD version of proposed findings  
4 of fact and conclusions of law to be delivered by end of business January 29, 2019  
5 to the Administrative Law Judge.

6           **February 18, 2019** – All parties are to submit written responses to the  
7 closing arguments. The responses by the Arizona Department of Health Services  
8 and Intervenors are limited to ten (10) pages in length; the response by Applicant  
9 is limited to thirty (30) pages.

10           **March 4, 2019** – The record will close fourteen (14) days after the receipt  
11 of the written responses. In the event the deadline for the written responses is  
12 extended for any reason, the closing of the record will be extended for the same  
13 length of time.
