8 **IT IS ORDERED** that the motions to intervene filed by Maricopa Ambulance and the
9 AMR entities are granted;

10 **IT IS FURTHER ORDERED** that the hearing in this matter is now scheduled to be
11 conducted on September 17, 18, 19, 20, 23, 24 and 25, 2019, beginning at 8:30 a.m. each
12 day. The parties are advised however, that the ALJ could not secure a large, first-floor hearing
13 room for September 17, 2019. Consequently, they should consult among themselves and
14 inform the tribunal if they prefer cancel that day of hearing.

15 **IT IS FURTHER ORDERED** that the following filing deadlines are set:

- 16 1. July 1, 2019 Responses to ABC's Motion for Rulings on Issues of Law;
- 17 2. August 8, 2019 ABC must file a list of the witnesses it intends to call in its case-
18 in-chief, with a fair summary of each witness's proposed testimony;
- 19 3. August 8, 2019 ABC must file its initial exhibits;¹
- 20 4. August 15, 2019 Intervenors and the Department must file a list of the witnesses
21 they intend to call in their cases-in-chief, with a fair summary of each witness's
22 proposed testimony;
- 23 5. August 15, 2019 Intervenors and the Department must file their initial exhibits;²
- 24 6. August 22, 2019 Each party must file its supplemental witness lists and exhibits;
- 25 7. August 22, 2019 Any requests for subpoenas for witnesses to appear at hearing or
26 subpoenas duces tecum for document production must be filed;
- 27 8. August 22, 2019 Any Prehearing Motions must be filed;
- 28 9. August 29, 2019 Responses to any outstanding Motions³ must be filed (no
29 Replies will be considered);
