Pursuant to R2-19-110, Applicant ABC Ambulance LLC hereby requests that the Administrative Law Judge (“ALJ”) continue the hearing currently scheduled to convene on September 18, 19, 20, 23 and 24, and October 1, 2 and 3, 2019 (see Case Management Order No. 6), to a date not sooner than January 20, 2020. Applicant’s counsel’s workload is such that she requires more time to prepare for the hearing.
