**RESPONSE TO LIFE LINE'S

22 The Arizona Department of Health Services, Bureau of Emergency Medical
23 Services and Trauma System (“BEMSTS” or “Bureau”) hereby responds to the Request
24 for Hearing Continuance and Prehearing Conference filed by Life Line Ambulance
25 Service, Inc. (“Life Line”). This matter is currently set for hearing on February 24,
26 2021 through February 26, 2021. Because the ALJ has granted the Motion to Intervene
27 filed by Life Line, BEMSTS believes the hearing in this matter will take longer than the
28 currently allotted three days for hearing. On that basis, the Bureau has no objection to a
continuance of the current hearing dates.

In addition, the Bureau agrees that a Prehearing Conference held pursuant to
A.A.C. R2-19-112 would be appropriate to discuss potential new hearing dates,
facilitate and streamline the parties’ preparation for the hearing, including establishing

1 deadlines to the filing and exchange of the parties' lists of witnesses and exhibits,
2 issuing subpoenas as necessary, and dealing with any prehearing motions filed in this
3 matter. So, on that basis as well, the Bureau has no objection to continuing the hearing
4 to facilitate such a prehearing process.
